

UTAH STATE BAIL SCHEDULE

The bail listed below for each of the offenses is to be considered the normal minimum fine which would be levied should a defendant be found guilty. Defendant should understand that the fine and surcharge for any of the offenses could be as high as \$1062.50 for any Infraction or Class C Misdemeanor and \$1,950.00 for any Class B Misdemeanor. For all violations not listed, defendant must contact the Court for bail amount and/or appointment.
