CALL TO ORDER: Mayor Griffiths called the meeting to order at 5:15 p.m.

ACTION MEETING:

1. Canvass of the November 2, 2021 General Election Vote Recount of November 15th, 2021

Mayor Griffiths read the results of the recount and declared the following candidates as the winners of the general election: Mollie Halterman, Mayor; Sharon Downey, City Council; and Rochell Topham, City Council.

Councilmember Burton asked if there were any changes. There was one ballot that was not adjudicated in the first count that was adjudicated in the recount. This gave one additional vote for Jim Harris and one additional vote for Rochell Topham. There was no change for Sharon Downey and David Harris.

MOTION: Councilmember Harris moved to accept the canvass recount for the November 2021 election for mayor and council.

SECOND: Councilmember Vesely seconded the motion.

VOTE: 5 Ayes/0 Nays. The motion carried. The canvass was approved and certified.

SECOND: Councilmember Gale seconded the motion.

VOTE: 5 Aye/0 Nay. The motion carried.

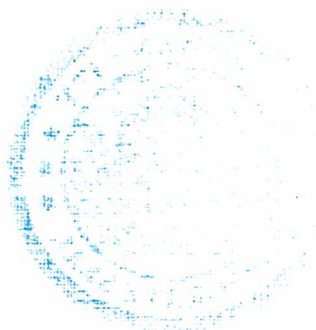
