

ORDINANCE NO. 2023-03-01
AN ORDINANCE ESTABLISHING THE TIMES FOR SALE
OF CERTAIN ALCOHOLIC BEVERAGES WITHIN
PAROWAN CITY.

WHEREAS, Parowan City, Iron County, State of Utah, a body politic, is a municipal corporation organized and established for the purpose of regulating certain commercial activities that have an affect or impact upon the community and its residents; and

WHEREAS, Pursuant to U.C.A. §32B-1-204, Parowan City may regulate an issue related to alcoholic product sales not addressed by the State of Utah, and which do not conflict with the Utah Alcoholic Beverage Control Act, (Utah Code Annotated title 32B).

WHEREAS All of the definitions, requirements, regulations, prohibitions, provisions and sections of The Utah Alcoholic Beverage Control Act, as amended, were adopted by Parowan City, and the Utah Alcoholic Beverage Commission;

WHEREAS, It has been brought to the attention of Parowan City that the Utah Alcoholic Beverage Control Act no longer regulates the sale of alcoholic beverages having an alcohol content of less than 3.5%; and

WHEREAS, Parowan City desires to regulate the hours of beer sales to be commensurate with the sale of other alcohol and deems that it is not in the best interest of customers to purchase alcohol during early morning hours for the safety of the community; and

WHEREAS, Parowan City has considered the matter in open meeting and received public comment; and


WHEREAS, Parowan City has determined that it is in the best interest of the City and its residents to reasonably regulate the hours that alcoholic beverages may be sold.

NOW, THEREFORE, IT IS HEREBY ORDAINED by the City Council of Parowan City, Iron County, Utah, that until further so ordered, sale of alcohol for off-premise consumption shall be as follows:

It shall be unlawful to sell or otherwise furnish or dispose of an alcoholic beverage, whether or not the premises are open to the public, during the following hours, according to license classification:

The permitted hours for sale of alcoholic beverages for off-premise consumption shall be between the hours of 5:00 a.m. and 11.59 p.m. Alcohol content shall be sold in accordance with the Utah Department of Alcoholic Beverage Commission rules and regulations.

This ordinance is hereby passed and adopted by the Parowan City Council on the 23rd day of March, 2023, and shall take effect on April 13, 2023.
