AN ORDINANCE TO UPDATE AND REPLACE PAROWAN CITY MUNICIPAL CODE 7.10.020 (B) CULINARY WATER COMMITTEE, 7.06.010 (B) IRRIGATION WATER COMMITTEE, 7.02.010 (F) QUALIFICATION OF BOARD MEMBERS, 2.14.010 AIRPORT BOARD, 2.14.020 (A)(1) BOARD TERMS, 2.14.040 (1) COMMISSION ESTABLISHED, 4.03.050 (B) RAP TAX COMMITTEE TO UPDATE MAKEUP REQUIREMENTS OF PAROWAN CITY AGENCIES, BOARDS, COMMITTEES, AND COMMISSIONS

ORDINANCE DATED AUGUST 22ND 2024

WHEREAS, Parowan City is a corporation created and existing under the laws of the State of Utah; and,

WHEREAS, Prior to this ordinance, some of the official Agencies, Boards, Committees, and Commissions established by the Parowan City Council have a residential requirement for the appointed members of those entities, and other do not. In the Councils view, this inconsistency is problematic; and,

WHEREAS, The Parowan City Council is desirous to make all official Agencies', Boards', Committees', and Commissions' appointed member participation to have a residential requirement.

WHEREAS, This ordinance modifies the makeup requirements of the Culinary Water Committee, Irrigation Water Committee, Airport Board, Theater Board, Shade Tree Commission, and RAP Tax Committee. All other official and unofficial Agencies, Boards, Committees, and Commissions of Parowan City remain unaffected by this ordinance; and,

WHEREAS, The Parowan City Council is also desirous to make other minor adjustments to the wording affecting the appointment process of the Culinary Water Committee, Irrigation Water Committee, and Parowan Shade Tree Commission, to make them consistent with the other Agencies, Boards, Committees, and Commissions processes.

NOW, THEREFORE, the City Council of Parowan City, Utah, hereby adopts and passes the following:

7.10.020 (B) Culinary Water Committee. A Culinary Water Committee shall be formed consisting of (5) persons, to be appointed the mayor with advice and consent of the City Council. The Culinary Water Committee shall make recommendations relating to the operation and management of the Culinary Water System except that the Committee shall be limited to the making of policy recommendations and not to rates or charges for connection and user fees which, because of bonded indebtedness, are revenues which by law and Bond Resolution must be reserved to the City Council. References herein to this "Committee" shall be deemed to mean the Culinary Water Committee hereby created. The five (5) members of the Committee shall be residents of Parowan City.

7.06.010 (B). Irrigation Water Committee. An Irrigation Water Committee shall be formed consisting of (5) persons, to be appointed the mayor with advice and consent of the City Council. The Irrigation Committee shall make recommendations relating to the operation and management of the Irrigation System except that the Committee shall be limited to the making of policy recommendations and not to rates or charges for connection and user fees which, because of bonded indebtedness, are revenues which by law and Bond Resolution must be reserved to the City Council. References herein to this "Committee" shall be deemed to mean the Irrigation Water Committee hereby created. The five (5) members of the Committee shall be residents of Parowan City.

7.02.010 (F). Qualification Of Board Members. The five (5) members of the Committee shall be residents of Parowan City.

2.14.010 Airport Board. An airport board, to be known as the Parowan City Airport Board, consisting of five members, is hereby created. The board members shall be appointed by the Mayor with the advice and consent of the City Council, and of the first board to be appointed, one member shall be a City Council Member appointed by the Mayor for one year at a time, two members for two years, and two members for three years and thereafter, all appointments shall be for three-year terms other than the Council Member. The Mayor and the Council shall designate which one on the board shall be its Chairman. The five (5) members of the Airport Board shall be residents of Parowan City.


2.14.020 (A)(1) BOARD TERMS. A Board of seven (7) persons, with one (1) alternate, is hereby established. One (1) elected official shall be appointed to the Board at all times. Said elected official shall be exempt from term limits herein set and shall be appointed by assignment of the Mayor and consent of the City Council. A term shall consist of two years with additional terms approved by the City Council upon reapplication of Board member. The terms shall be staggered as directed by the City Council. Terms of office expire on June 30 of each year. The Theater Manager shall not be considered a member of the Theater Board. The seven (7) members of the Theater Board shall be residents of Parowan City.

2.14.040 (1) Commission Established. There is hereby created a Shade Tree Commission consisting of seven members. The City Manager shall designate an employee of the City to serve on the Shade Tree Commission, and the Mayor shall appoint a City Councilman to serve as appointed members of the Shade Tree Commission. The remaining five members shall be appointed by the Mayor with the advice and consent of the City Council. The seven (7) members of the Commission shall be residents of Parowan City.

4.03.050 RAP Tax Committee

(B) The advisory committee shall be comprised of five (5) people to be appointed by the Mayor with the advice and consent of the City Council, who are residents of the City of Parowan. The Mayor shall appoint one (1) member of the City Council to serve on the committee with advice and consent of the City Council. The term of office for the City Council representative shall correspond to the tenure as a City Councilperson. The term of office for the other four (4) members of the committee shall be for four (4) years. The advisory committee shall nominate and elect one of its members to serve as the chairperson. The chairperson shall conduct all meetings of the committee, but shall not vote unless there is a tie. In order to conduct business, there must be a quorum of three members present. The City Council may remove any member of the committee for cause and after a public hearing, if such hearing is requested. If a member of the committee should resign, the Mayor shall appoint a replacement to serve of the remainder of the resigning person's term. The five (5) members of the Committee shall be residents of Parowan City.


