Mr. Melling shared a power point presentation with all present, dealing with how overage was enacting costs and burdens on the City's culinary water system. Mark Carney shared a presentation with all present and discussed, at length, with the board and staff specifics regarding water tier systems and conservation measures that could benefit Parowan City. The board focused on trying to creating tiers that were justifiable and reasonable, supporting residents who already conserved, and encouraging those with high water usage to choose to conserve.
